
Description of this fund

The Kernel NZ Level 9 Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX Emerging Opportunities Index.

What are the risks of investing?

Risk indicator for the Kernel NZ Level 9 Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Emma had \$10,000 in the fund on 28 August 2019 and did not make any further contributions. On 30 September 2019, Emma received a return after fund charges were deducted of \$284 (that is 2.84% of her initial \$10,000). This gives Emma a total return after tax of \$275 for the period.
