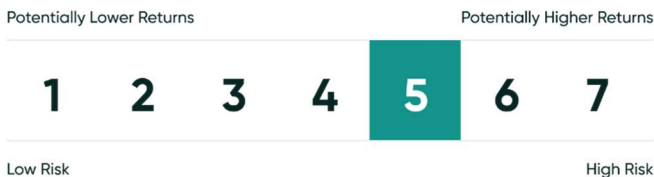
Description of this fund

The Kernel NZ Small & Mid Cap Opportunities Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX Emerging Opportunities Index.

What are the risks of investing?

Risk indicator for the Kernel NZ Small & Mid Cap Opportunities Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

What fees are investors charged?

Investors in the Kernel NZ Small & Mid Cap Opportunities Fund are charged fund charges. In the year to 31 March 2020 were:

Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Emma had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Emma received a return after fund charges were deducted of \$597.91 (that is 5.98% of her initial \$10,000). This gives Emma a total return after tax of \$584.11 for the period.
