What is the purpose of this update?

This document tells you how the Kernel NZ 20 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel NZ 20 Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX 20 Index.

What are the risks of investing?

Risk indicator for the Kernel NZ 20 Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

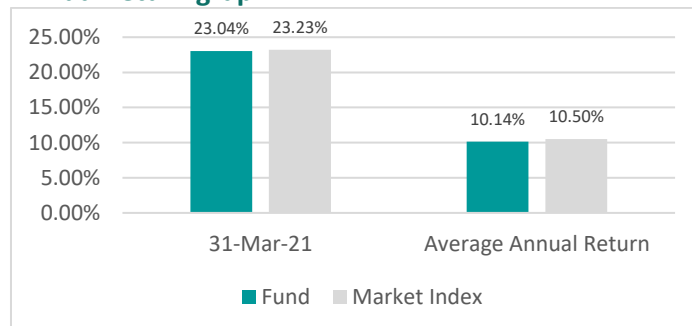

What fees are investors charged?

Investors in the Kernel NZ 20 Fund are charged fund charges. In the year to 31 March 2021 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

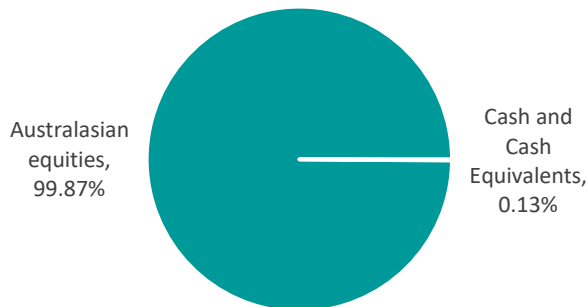
Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 July 2020 and did not make any further contributions. On 30 June 2021, Emma received a return after fund charges were deducted of \$724.49 (that is 7.24% of her initial \$10,000). This gives Emma a total return after tax of \$654.89 for the year.

Notes

1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 3 years and 2 months of market index returns.
