**\$10,000 invested 5 years ago<sup>6</sup>: \$19,590**



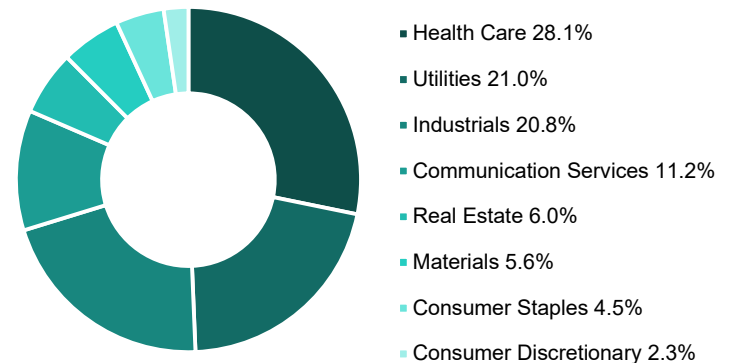
## Where does the fund invest?

## Index Eligibility Criteria

The index is weighted by float-adjusted market capitalization, to a maximum weight of 15% at rebalancing reference dates
